The 2012 Magnolia Summerfest will be held at the Magnolia Playfield at the corner of 32nd Ave West and West Smith and adjacent streets. The festival is an official Seafair-sanctioned Community Event scheduled for **Friday, August 3rd and Saturday, August 4th**. Activities include live entertainment, children's stage and rides, craft booths, food booths, the largest children's parade in the state and the annual Magnolia Seafair parade on Saturday, August 4th.

Summerfest is seeking a variety of food vendors serving quality food products. This Festival, while not among the largest, does attract clientele interested in quality and originality. Those wishing to participate must return their application with fees no later than June 15th, 2012 to secure a place. Only 10 spaces available!

Saturday, August 4th, 10:00 am – 6:00 pm
- Set Up:** Thursday, August 2nd after 4:00 pm
Friday, August 3rd before 11:00 am
- Fees:** \$350 for one 10' X 10' space (additional fee for larger space)

City of Seattle Business License. If you do not have a valid Seattle Business License an additional fee of \$5.00 per day will be charged and is payable at time of application.

Food Handling Permit. Food handling permits are required for all those serving food. Permits are issued by Public Health – Seattle King County located at 2124 4th Ave. (4th Floor); Seattle, WA 98121 (206) 296-4772.

Food packaging: All Summerfest Food vendors must provide compostable or recyclable food service products and take-out packaging (SMC 21.36.086). No Styrofoam food service products will be permitted on the site.

Fire Permit: Fire permits are required for the use of liquid petroleum gas or open wood or charcoal fires. Contact the Seattle Fire Marshall at (206) 386-1355 or (206) 386-1209.

Booth Space: Summerfest provides the 10' X 10' booth space only. Vendor supplies canopies, signage and 100 feet of electrical cord if needed. Security is provided Thursday and Friday nights.

Insurance: All Summerfest vendors must provide proof of liability insurance. If you are accepted as a Summerfest Food Vendor you will not be allowed to set up your booth without proof of insurance.

Refund Policy: No refunds will be issued after July 15, 2012

The annual Magnolia Summerfest will be held on **Friday, August 3rd & Saturday, August 4th** at the Magnolia Playfield at 32nd Avenue West and West Smith Street. Food vendors will be set up on West Smith Street Between 32rd Avenue West and 33rd Avenue West.

The following must be provided by all food vendors:

1. A current City of Seattle Business License (or \$5 per day charge in lieu).
2. Current Food Handling permits for all persons serving food.
3. A Fire Permit if you plan to use gas or wood/charcoal fires for cooking.
4. Power cord –three-prong, 100 feet long.
5. Adequate signage indicating prices of all items.
